Uralkali Announces Q3 2013 Production Results			
<p>Uralkali (LSE; URKA; the Company) has announced its production results for Q3 and the first 9 months of 2013. Uralkali produced 2.7 million tons of potassium chloride (KCl) in the third quarter of 2013 which represents a 5% increase compared to the corresponding period of the previous year. The Company produced 7.2 million tons of KCl in January-September 2013.</p> <p>3Q 2013 – 2.7 mln tons 3Q 2012 – 2.6 mln tons 9M 2013 – 7.2 mln tons 9M 2012 – 7.4 mln tons</p> <p><i>Uralkali (www.uralkali.com) is one of the world's largest potash producers with a share of about 20% in global potash production. The Company's assets consist of 5 mines and 7 ore-treatment mills situated in the towns of Berezniki and Solikamsk (Perm Region, Russia). Uralkali employs ca.11 800 people (in the main production unit).
