2.1. A shareholder of PJCS Uralkali - RINSOCO TRADING CO. LIMITED – submitted a demand to repurchase securities of PJSC Uralkali in compliance with article 84.8 of the Federal Law On Joint Stock Companies No. 208-FZ dated December 26, 1995 (hereinafter the JSC Law).

As at the end of the operational day of the date on which the owners of the securities being repurchased are identified, the registrar of the company and nominal holders of shares shall make a record of restriction of disposal of the securities being repurchased (on the depo accounts) without the permission (order) of the person for whom the account (depo account) was opened. The restriction of disposal of the securities being repurchased shall be lifted, if the person that submitted the demand to repurchase has not provided the registrar of the company with documents confirming that the payment for the securities being repurchased was made in compliance with article 84.8 of the JSC Law.

Owners of securities being repurchased that are registered in the share register of the company may submit applications to the registrar containing the details of their bank accounts where the funds for the securities being repurchased must be transferred. Applications shall be considered submitted in a timely manner, if they are received by the registrar of the company not later than on the date on which the owners of the securities being repurchased are identified.
