2.4. Date when the owners of the issuer's bonds acquired the right to demand early redemption of such bonds: **December 27, 2019.**

2.5. Grounds/circumstances due to which the bonds owners' right to demand early redemption of the issuers bonds was terminated: ***Expiration of a 30-day period following the publication of the last notice of reorganization of PJSC Uralkali during which the owners of the Exchange-Traded Bonds had the right to apply to courts seeking early performance of obligations – redemption of the Exchange-Traded Bonds of PJSC Uralkali. The indicated period expired on March 27, 2019.***

2.6. Date from which the bonds owners' right to demand early redemption of such bonds was terminated: **March 30, 2020.**
